

# EXECUTIVE DIRECTOR'S REPORT

#### CONSORTIUM GOAL ONE

Facilitate professional development, which supports the effective implementation of: 1. The Alberta Education Business Plan 2. Jurisdiction and school educational plans 3. Regional School Council priorities

The ARPDC 2021-22 Annual Report and the NRLC 2021-22 Annual Report have been presented to the CASS Board and are now available on our website to our Zone 1 School Division and Authorities at <u>https://nrlc.net/about</u>.

In January, NRLC hosted advisory consultations with two of our priority area committees including the Numeracy/Math and Literacy, and the Executive Director also met with the French Language Resource Centre Board and the Mighty Peace Teachers' Convention Association in preparation for upcoming professional learning. NRLC continues to host sessions for parents both virtually and in person, with January's parental offering being a collaboration with Peace Collaborative Services.

### CONSORTIUM GOAL TWO

Facilitate professional development, which supports the effective implementation of curricula, including instruction, assessment, resources and student learner outcomes

From January 1 - 30, 2022 the NRLC hosted **16** sessions, with **86** learning hours, and **179** participants.

### **CONSORTIUM GOAL THREE**

Coordinate, broker, and act as a referral centre to assist stakeholders to identify available professional development resources.

As previously reported, Grades 7-9 resources with Nehiyaw, Cree, Ways of Knowing and Being have been completed and added to the <u>Infusing Indigenous Learning into Curriculum</u> Website. Grade 10-12 core subject documents are undergoing their final review and are expected to be available on the website in February or early March.

### **CONSORTIUM GOAL FOUR**

Deliver professional development based on the identified and emerging needs of educational stakeholders.
