

EXECUTIVE DIRECTOR'S REPORT

CONSORTIUM GOAL ONE

Facilitate professional development, which supports the effective implementation of: 1. The Alberta Education Business Plan 2. Jurisdiction and school educational plans 3. Regional School Council priorities

During October, NRLC held Advisory meetings with the NRLC Regional Stakeholders Committee as well as the Literacy and First Nation, Metis and Unit committees. The NRLC Annual Learning Plan has been shared with the regional advisory committee as well as the ARPDC Provincial Advisory Committee. Also in October, NRLC hosted 2 evening parent sessions: An Evening with Shelly Moore and The Role School Council Plays in your School's Assurance Plan, in partnership with ASCA.

CONSORTIUM GOAL TWO

Facilitate professional development, which supports the effective implementation of curricula, including instruction, assessment, resources and student learner outcomes

It has been a busy fall with a return to many face to face learning opportunities across the zone. While virtual and asynchronous learning are still in demand, live face to face learning makes up about 40% of our programming to date.

From October 1 - 30, 2022 the NRLC hosted **27** sessions, with **241.5** learning hours, and **842** participants.

CONSORTIUM GOAL THREE

Coordinate, broker, and act as a referral centre to assist stakeholders to identify available professional development resources.

NRLC is currently offering 8 e-courses, created by NRLC/ARPDC staff as asynchronous session resources open to participation across the province. Of these e-courses, 5 are focused on New Curriculum. We have had 113 participants engage in our e-courses, 106 of which were for New Curriculum.

CONSORTIUM GOAL FOUR

Deliver professional development based on the identified and emerging needs of educational stakeholders.

October's Zone 1 collaborative programming was comprised of **15** learning opportunities including:

CONSORTIUM GOAL FIVE

October saw the completion of The Assurance Framework series with a total of 37 participants. The follow-up series Refocusing on Instructional Leadership continues in November with 77 registered participants.
